## STATE-OWNED ENTERPRISES (AMENDMENT) ACT 2016

5 A BILL FOR AN ACT to amend section 618, subsection 3 of Chapter 6, Title 52 of  
6 the MIRC, the State-Owned Enterprises Act, 2015 to allow the Minister to appoint at  
7 least one but not more than 3 public officials who shall be appointed by merits,  
8 experience and qualifications in order to contribute significantly to the economic  
9 and well-being of the people of the Marshall Islands.

10 BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

11 **§1. Short Title.**

12 This Act may be cited as the State-Owned Enterprises (Amendment) Act  
13 2016.

14 **§2. Amendment.**

15 Section 618(3) of the State-Owned Enterprises Act is amended as follows:

16 “Section 618. Directors appointment and qualifications.

- 17 (3) The Minister may appoint a ~~public official to be a director of a~~  
18 ~~State-owned enterprise but only for a term that~~ by merits, at  
19 least one but not more than 3 public officials with the approval  
20 of the Cabinet, whose experience, education and qualifications  
21 shall have significant contributions to the economic and  
22 general well-beings of the people of the Republic.”

**§3. Effective Date.**

2

This Act shall take effect on the date of certification in accordance with the Constitution of the Republic of the Marshall Islands and Rules of Procedures of the Nitijela.
