This Act may be cited as the Constitutional Convention (Amendment) (6) Act 2016.

(1) Schedule 1 of the Constitutional Convention Act, 2015 is amended by adding a new proposal No.25 to be inserted after proposal No.24 to read as follows:

“Proposal No. 25 -Article VII, the Public Service Commission: To amend Article VII of the Constitution in order to eliminate the Public Service Commission in its entirety and to establish Human Resources Offices in each of the Government Ministries.
