RESOLUTION 79

5 **A RESOLUTION** to express the gratitude and deep appreciation of the Marshallese  
6 people for the great and distinguished services performed by Professor Andrew  
7 Garrod by awarding him Honorary Citizenship of the Republic of the Marshall  
8 Islands.

10 **WHEREAS**, Professor Andrew Garrod is known amongst the people of the  
11 Republic of the Marshall Islands as a “music man”, who brought joy to many  
12 people including young children through his work of art in theatre production; and

13 **WHEREAS**, Professor Andrew Garrod has been involved in the theatre production  
14 in the Republic for the past 14 years; and

15 **WHEREAS**, from 2006 to 2017, Professor Andrew Garrod had produced number of  
16 screenplays and utilized many of whom involved in the productions are  
17 extraordinary indigenous talents (Marshallese talents) including the most recent  
18 “Oklahoma 2017”, “The King and I 2016”, “Guys and Dolls 2015”, “Fiddler on the  
19 Roof 2014”, “Westside Story 2013”, “As You Like It 2012”, “Tempest 2011”, “Hamlet  
20 2010”, “Much Ado About Nothing 2010”, “Romeo and Juliet 2013”, “Twelfth Night  
21 2014” and “Midsummer Night’s Dream 2006”; and

22 **WHEREAS**, Professor Andrew Garrod’s work of art in theatre production engaged  
23 many youth from different schools around Majuro Atoll including private and  
24 public schools; and

1 **WHEREAS**, Professor Garrod graduated from School of Education at Harvard  
2 University in the year 1976 with a Masters Degree (Ed.M.), Doctorate (Ed.D) in the  
3 year 1982, M.A from Oxford University in 1967, Diploma in Education from Oxford  
4 University in 1962 and Bachelor from Oxford University 1961; and

5 **WHEREAS**, Professor Garrod was a Profession Emeritus of Education, Dartmouth  
6 College in the year 2010 and a Department Chair from the year 1996 to 2010; and

7 **WHEREAS**, Professor Garrod's has taught at Dartmouth College for 25 years and  
8 was twice winner of the Distinguished Teaching Award, one of only 3 or 4 professors  
9 to be given the award more than once in the history of the award; and

10 **WHEREAS**, Professor Garrod also received the Annual Faculty Award "In  
11 Recognition of Your Support Of the Advancement Of Women, Both Academically  
12 and Socially" from the Dartmouth College Panhellenic Council; and

13 **WHEREAS**, Professor Garrod's also received profiles in Excellence Award from the  
14 Dartmouth College Student Assembly; and

15 **WHEREAS**, Professor Garrod received as an inaugural winner of the Good Work  
16 Award from the Association for Moral Education: "In recognition of outstanding  
17 moral practice in Bosnia, the Marshall Islands and United States" in the year 2008;  
18 and

19 **WHEREAS**, Professor Garrod's also received the Doctor of Letters Honorary Degree  
20 and was a Convocation Speaker awarded for "commitment to promotion  
21 international understanding through the arts" at the University of New Brunswick,  
22 Canada, 2017; and

23 **WHEREAS**, Professor Garrod also received two prize-winning documentary movies  
24 which have been made of youth plays he directed in Rwanda and Bosnia-  
25 Herzegovina; and

26 **BE IT RESOLVED** by the People of the Republic of the Marshall Islands through  
27 their Nitijela in its 40<sup>th</sup> Constitutional Regular Session, 2019, that Nitijela hereby  
28 express its gratitude and deep appreciation to Professor Andrew Garrod by  
29 awarding his Honorary Citizenship of the Republic of the Marshall Islands; and

1 **BE IT FURTHER RESOLVED** that the Speaker of the Nitijela transmits certified  
2 copy of this Resolution to Professor Andrew Garrod and other pertinent parties.


