**CONSTITUTIONAL CONVENTION (AMENDMENT) ACT  
2017**

**AN ACT** to amend Schedule 1 of the Constitutional Convention Act of 2015 to include a new proposal to amend Article III Section 1 (2)

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Constitutional Convention (Amendment) Act 2017.

**§102. Amendment.**

(2) The Council of Iroij shall consist of 5 eligible persons from districts of the Ralik Chain and 7 eligible persons from districts of the Ratak Chain of the Republic selected as follows:

- from the Ralik Chain excluding Enewetak and Ujelang .....4 Irojilaplaps
- from Enewetak and Ujelang.....1 Irojilaplap
- from Mili..... 1 Irojilaplap
- from Arno..... 1 Irojilaplap
- from Mejit..... 1 Irojilaplap
- from Majuro.....1 Irojilaplap
- from Airok (Maloelap)..... 1 Irojilaplap

from Aur, Maloelap (excluding Airok), Wotje, Utrik and Ailuk  
..... 1 Iroiylaplap  
from Likiep..... 1 Owner

**§103. Effective Date.**

This Bill shall take effect in accordance with the Constitution and the Rules of Procedures of the Nitijela.
