RESOLUTION 46

A **RESOLUTION** requesting that the Nitijela approve the Cabinet's appointment of the Honorable Nixon David to serve as the Associate Judge of the Traditional Right Court and judge representing Iroij interests from the date of appointment for a term of 4 years.

WHEREAS, the second four-year term of Associate Judge of the Traditional Rights Court Nixon David expires on April 6, 2021; and

WHEREAS, Associate Judge Nixon David has expressed his willingness to serve as the Associate Judge of the Traditional Rights Court and judge representing Iroij interests from the date of appointment for a term of 4 years; and

WHEREAS, Associate Judge Nixon David has served the Republic well during his past two terms as an Associate Judge of the Traditional Rights Court; and

WHEREAS, Associate Judge Nixon David is an expert on the customary law and traditional practise of the Marshall Islands; and

WHEREAS, Associate Judge Nixon David has the communication skills and experience necessary for the proper operation of the Court; and

WHEREAS, Associate Judge Nixon David as over the past 8 years participated in workshops and seminars to enhance his knowledge, skills and abilities; and

WHEREAS, on March 25, 2021, the Cabinet, upon the recommendation of the Judicial Service Commission, appointed the Honorable Nixon David to serve as the Associate Judge of the Traditional Rights Court and judge representing Iroj interests from the date of his appointment for a term of 4 years effective April 7, 2021; and

NOW THEREFORE, BE IT RESOLVED by the people of the Republic of the Marshall Islands, through their Nitijela in its 42nd Constitutional Regular Session, 2021, that the Nitijela hereby approves the appointment of the Honorable Nixon David to serve as the Associate Judge of the Traditional Rights Court and judge representing Iroj Interests from the date of appointment for a term of 4 years, effective April 7, 2021.
