RESOLUTION 85

A RESOLUTION approving the appointment of Chief Justice Carl B. Ingram as the Chief Justice of the High Court of the Republic of Marshall Islands.

WHEREAS, the second ten-year term for Chief Justice Carl B. Ingram as the Chief Justice of the High Court of the Republic expires on October 5, 2023; and

WHEREAS, having considered his excellent performance and dedication over the past twenty years, the Judicial Service Commission voted unanimously (with Chief Justice Ingram abstaining) to recommend to the Cabinet that it appoint Chief Justice Ingram for a ten-year term October 5, 2023; and

WHEREAS, on January 26th 2023, on the recommendation of the Commission, the Cabinet appointed Chief Justice Ingram as the Chief Justice of the High Court for a ten-year effective October 5, 2023; and

WHEREAS, in addition to his current service on the High Court bench, Chief Justice Ingram has a long record of distinguished service to the Republic as a Peace Corps Volunteer in 1979 to 1981, as Deputy Attorney- General, Legal Counsel in 1981 to 1988, as counsel for various government authorities in 1984 to 1996, and as an Associate Justice of the High Court from March 2003 to October 2003; and

WHEREAS, Chief Justice Ingram has expressed a keen interest in continuing to serve the Republic as the Chief Justice of the High Court; and

NOW THEREFORE, BE IT RESOLVED, by the People of the Republic of the Marshall Islands, through their Nitijela in its 44th Constitutional Regular Session, 2023, that the Nitijela approve, and the Nitijela does hereby approve, the appointment of Chief Justice Carl B. Ingram as the Chief Justice of the High Court of the Republic for a ten-year term, effective October 5, 2023.
