## **RESOLUTION 92**

A **RESOLUTION** to approve the appointment of Mrs. Anjanette Kattil as Ambassador Extraordinary and Plenipotentiary of the Republic of the Marshall Islands to the Republic of China (Taiwan) and Non-Resident Ambassador to neighboring Asian countries specifically, the Republic of the Philippines, Indonesia, Malaysia, Cambodia, Vietnam, and Singapore.

**WHEREAS**, at its meeting on February 24, 2023, the Cabinet appointed Mrs. Anjanette Kattil as Ambassador Extraordinary and Plenipotentiary of the Republic of the Marshall Islands to the Republic of China (Taiwan) and Non-Resident Ambassador to the neighboring Asian countries specifically, the Republic of the Philippines, Indonesia, Malaysia, Cambodia, Vietnam and Singapore.

**WHEREAS**, Mrs. Anjanetter Kattil is qualified by education, experience, character and reputation to hold office as Ambassador Extraordinary and Plenipotentiary of the Republic of the Marshall islands to the Republic of China (Taiwan) and Non-Resident Ambassador to neighboring Asian countries specifically, the Republic of the Philippines, Indonesia, Malaysia, Cambodia, Vietnam and Singapore.

**WHEREAS**, the appointment of Mrs. Anjanette Kattil as Ambassador requires the approval of the Nitijela is signified by Resolution in accordance with Article V, Section 1(3)(d) of the Constitution and further under Section 613(2) of the Foreign Affairs Act;

**NOW, THEREFORE, BE IT RESOLVED** by the People of the Republic of the Marshall Islands, through their Nitijela in its 44<sup>th</sup> Constitutional Regular Session,

2023, that for purposes of Article V, Section 1(3) (d) of the Constitution and Section 613(2) of the Foreign Affairs Act, the Nitijela approve, hereby approves, the appointment of Mrs. Anjanette Kattil as Ambassador Extraordinary and Plenipotentiary of the Republic of the Marshall Islands to the Republic of China (Taiwan) and Non-Resident Ambassador to neighboring Asian countries specifically, the Republic of the Philippines, Indonesia, Malaysia, Cambodia, Vietnam and Singapore.
