**HEALTH FUND (AMENDMENT) ACT, 2018**

**AN ACT** to amend Section 211(2)(b) of the Marshall Islands Health Fund of 2002 to allow the Health Fund to be used for the salaries of doctors.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Marshall Islands Health Fund (Amendment) Act, 2018.

**§102. Amendments.**

Section 211 of the Health Fund Act us amended to read as follow:

**1) §211. Payments out of the Health Fund.**

Pays may be made out of the Health Fund only for the purposes of this Chapter, and in the following manner:

- (2) The remaining forty-five percent (45%) shall be utilized as follows:
  - (b) the remainder of the Fund (45%) shall be utilized for:
    - (iii) the costs and expenses of the administration of the Fund under this Chapter;
    - (iv) for improving on-island health care;
    - (v) salaries of specialized doctors; and
    - (vi) sitting fee for Board members, except for Minister, in the sum of \$100.00 per sitting day.

§103. **Effective Date.**

This Act shall take effect in accordance with the Constitution and the Rules of Procedures of the Nitijela.
