- (4) The appointment of the members of the Parole Board shall be on a part-time basis, and except a member who otherwise holds a salaried office under the Government of the Republic, members shall be entitled to receive such compensation for their services as the Cabinet may determine.

(2) A new subsection (5) is hereby inserted under section 304 to read as follows:

(5) The quorum of the Board shall be four (04) members.

Section 3. Effective Date

This Act shall take effect on the date of certification in accordance with the Constitution and the Rules of Procedures of the Nitijela.
