**A
RESOLUTION**

To express gratitude and appreciation on behalf of the Nitijela, the Government and the People of the Republic of the Marshall Islands to Honorable Senator Tomaki Juda for his tenure and service as Senator and Vice-Speaker of the Nitijela of the Republic of the Marshall Islands.

WHEREAS, Senator Tomaki Juda was elected in 2001 as a member of the Nitijela representing the people of Kili, Bikini and Ejit (KBE), and has served in that capacity as Senator for the last (16) sixteen years; and

WHEREAS, on January 3, 2014, Senator Tomaki Juda was elected to the Office of the Vice-Speaker of the Nitijela, Republic of the Marshall Islands and has served in that capacity for more than (2) two years until his resignation from the office due to ill health; and

WHEREAS, during his tenure as a member of the Nitijela, Senator Tomaki Juda served in various Standing Committees of the Nitijela including the Appropriations Committee (APPRO), the Committee on Foreign Affairs and Trade (FAT), the Judiciary and Governmental Relations Committee (J&GR), the committee on Resources and Development (R&D), and as Chairman for the committee on Health, Education & Social Affairs (HESA); and

WHEREAS, Senator Tomaki Juda officially tendered his resignation to serve as a Member of the Nitijela, which took effect on August 30, 2015; and

WHEREAS, Senator Tomaki Juda has been under medical referral in Hawaii since his resignation from the Office of the Vice Speaker; and

1 **WHEREAS**, it is fitting that the Nitijela of the Republic of the Marshall Islands,
2 on behalf of the Government and the People, wishes to express their utmost gratitude and
3 appreciation to Senator Tomaki Juda for the many years of outstanding services; now
4 therefore,

5 **BE IT RESOLVED** by the People of the Republic of the Marshall Islands,
6 through their Nitijela, at its 36th Constitutional Regular Session, 2015; and the Nitijela
7 hereby expresses it's gratitude and appreciation to Senator Tomaki Juda for his service to
8 the Nitijela, the Government and the People of the Republic of the Marshall Islands,
9 especially to the people of Kili, Bikini, Ejit (KBE); and

10 **BE IT FURTHER RESOLVED** that a certified copy of this Resolution be
11 transmitted by the Clerk of the Nitijela to Senator Tomaki Juda.


