RESOLUTION 29ND1

A RESOLUTION to amend the appointment of Mrs. Neijon Edwards as Ambassador Extraordinary and Plenipotentiary to the Republic of China (Taiwan) to be cross-accredited as Ambassador to the following countries in Asia; Republic of Philippines, Republic of Indonesia, Malaysia, Kingdom of Cambodia, Socialist Republic of Vietnam, and the Republic of Singapore.

WHEREAS, at its meeting on September 12, 2018, the Cabinet appointed Mrs. Neijon Edwards as Ambassador Extraordinary and Plenipotentiary and Head of Mission to the Republic of China (Taiwan); and

WHEREAS, the Cabinet approved the cross-accreditation of Ambassador Mrs. Neijon Edwards as RMI Ambassador to the Republic of China (Taiwan) to be cross-accredited as Ambassador to the following countries in Asia; Republic of Philippines, Republic of Indonesia, Malaysia, Kingdom of Cambodia, Socialist Republic of Vietnam, and the Republic of Singapore; and

WHEREAS, the cross-accreditation of Ambassador Mrs. Neijon Edwards as Ambassador to the Republic of China (Taiwan) and a non-resident Ambassador to the following countries in Asia; Republic of Philippines, Republic of Indonesia, Malaysia, Kingdom of Cambodia, Socialist Republic of Vietnam, and the Republic of Singapore requires the approval of the Nitijela signified by this Resolution in accordance with Article V, Section 1 (3) of the Constitution and under Section 613 (1) (b) of the Foreign Affairs Act; and, now therefore;

BE IT RESOLVED by the People of the Republic of the Marshall Islands, through their Nitijela in its 42nd Constitutional Regular Session 2021, that for the purposes of Article V, Section 1(3)(d) of the Constitution and Section 613(1)(b) of the Foreign Affairs Act, the Nitijela hereby approves the cross-accreditation of Ambassador Neijon Edwards to Republic of China (Taiwan) to be cross-accredited to the following countries in Asia; Republic of Philippines, Republic of Indonesia, Malaysia, Kingdom of Cambodia, Socialist Republic of Vietnam and the Republic of Singapore.
